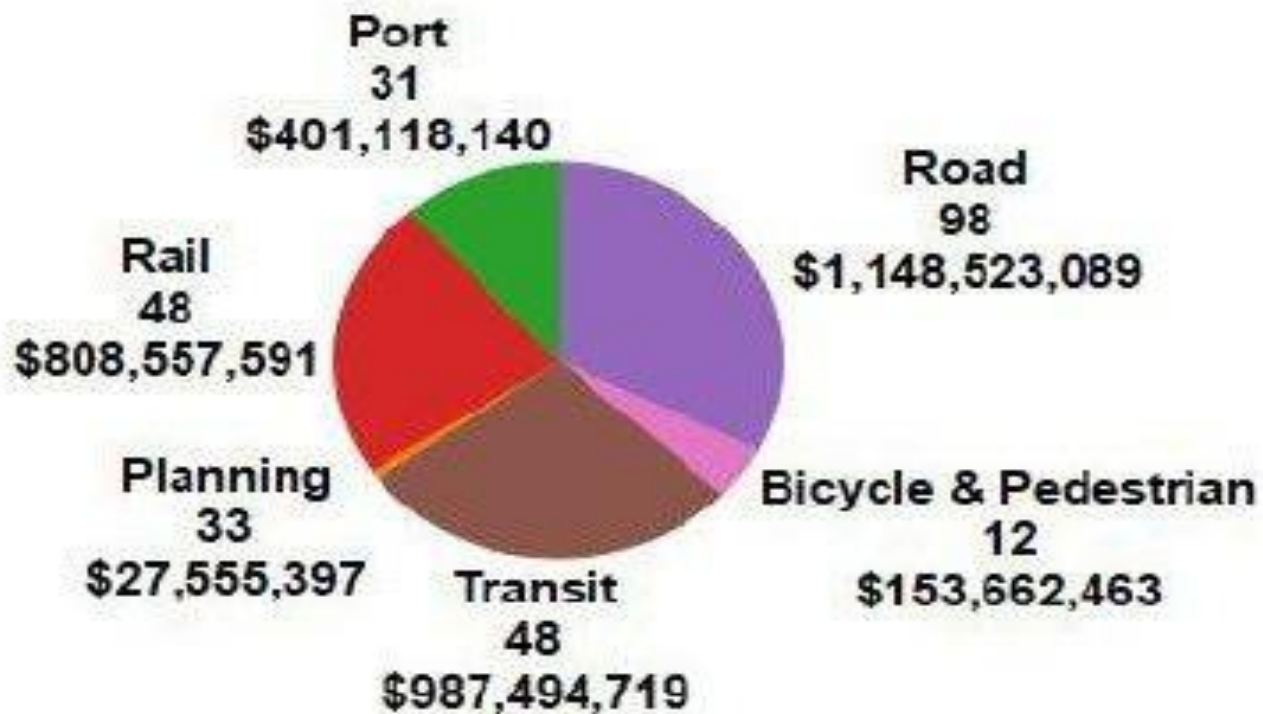

About TIGER Funding

- TIGER Funding—"A unique opportunity to invest in road, rail, transit and port projects that promise to achieve critical national objectives".
- Created by Congress in 2009.
- Six Rounds have resulted in \$4.1 billion in project funding.
