

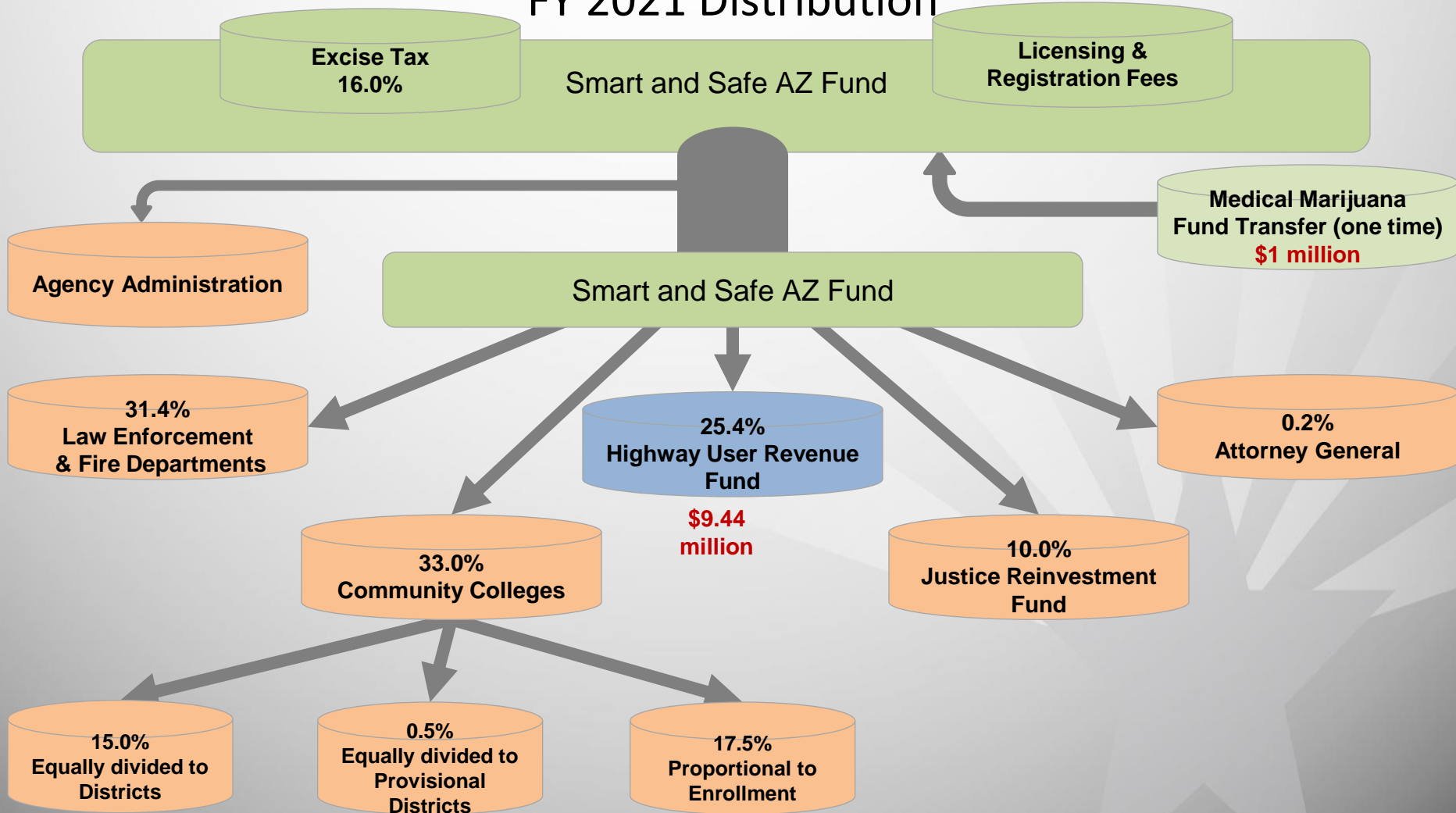

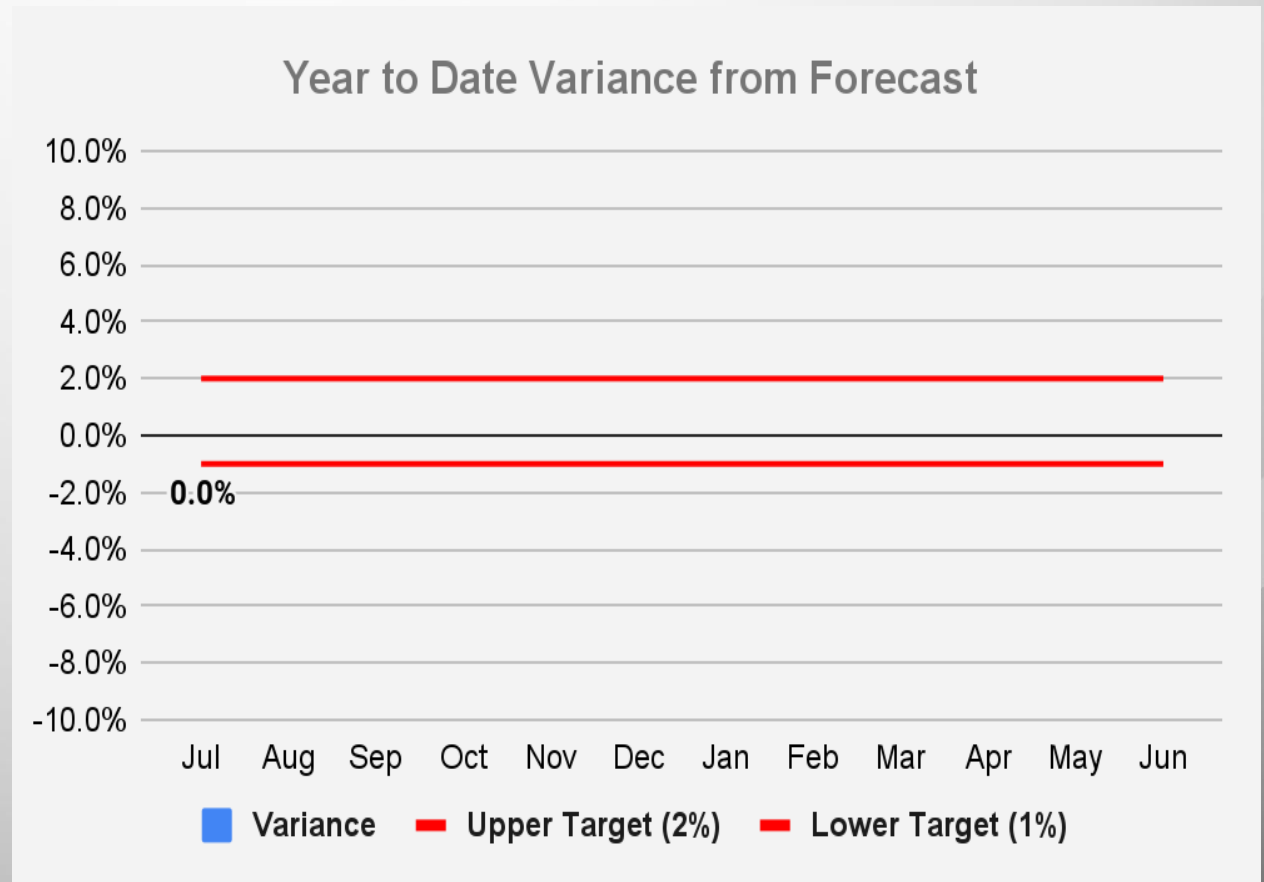
## FY 2021 Distribution



# Revenue Report:

## Highway User Revenue Fund (HURF)

- **GAS TAX - Strong growth month (14.1%)**
- **DIESEL TAX - Strong growth month (28.4%)**
- **VLT - Moderate decline month (-3.4%)**
- **REGISTRATION - Moderate growth month (7.7%)**

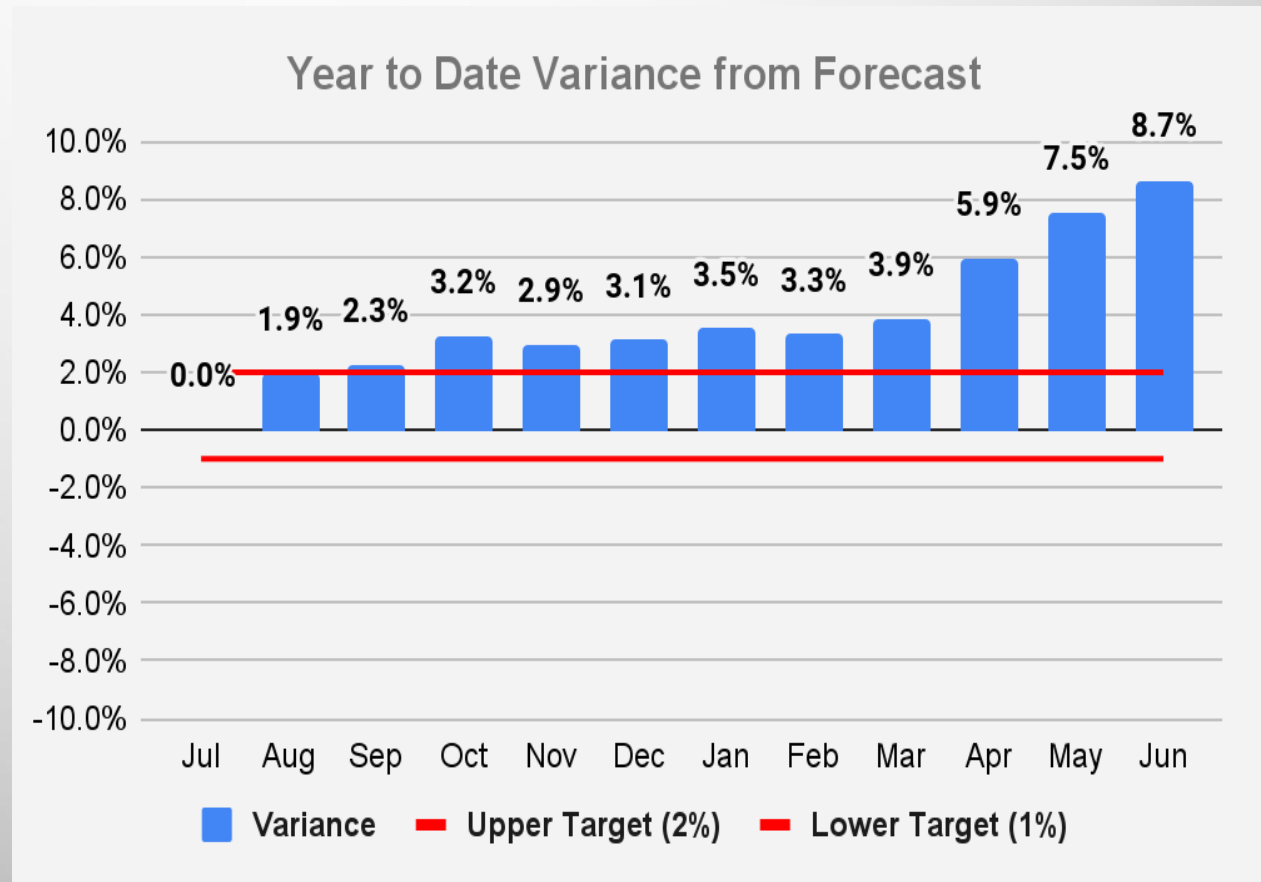

- July actual
- Supplier sells fuel in June, file their fuel tax report in late July, and funds distributed during July HURF close in early August.
- July fuel numbers reflect June sales.
- July VLT numbers reflect the last ½ of June and the 1st ½ of July.

- **RETAIL SALES - Strong growth month (23.8%), strong growth FY 2021 (22.3%)**
- **CONTRACTING - Moderate growth month (16.2%), strong growth FY 2021 (6.2%)**
- **RESTAURANT & BAR - Strong growth month (55.6%), strong decline FY 2021 (4.4%)**

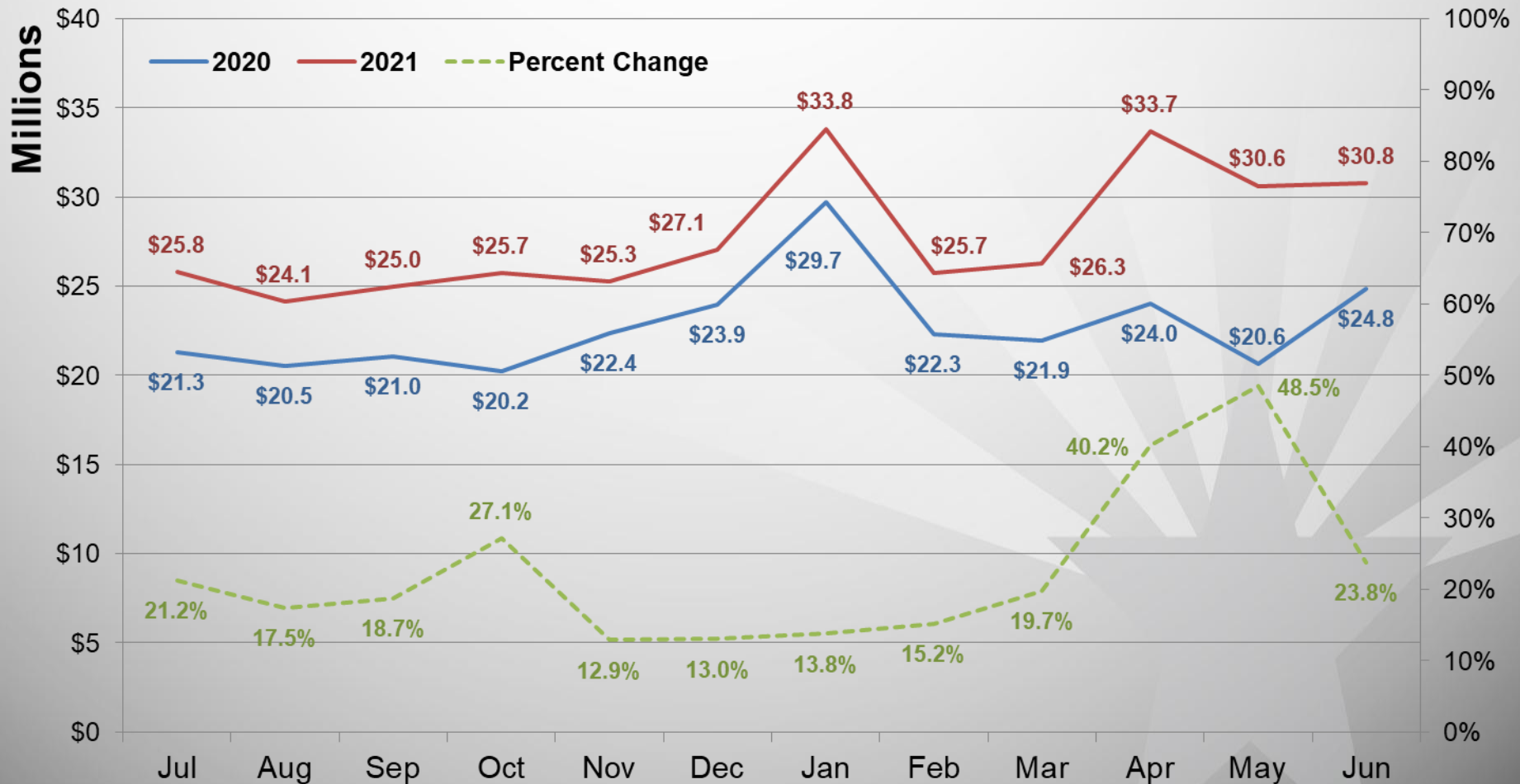

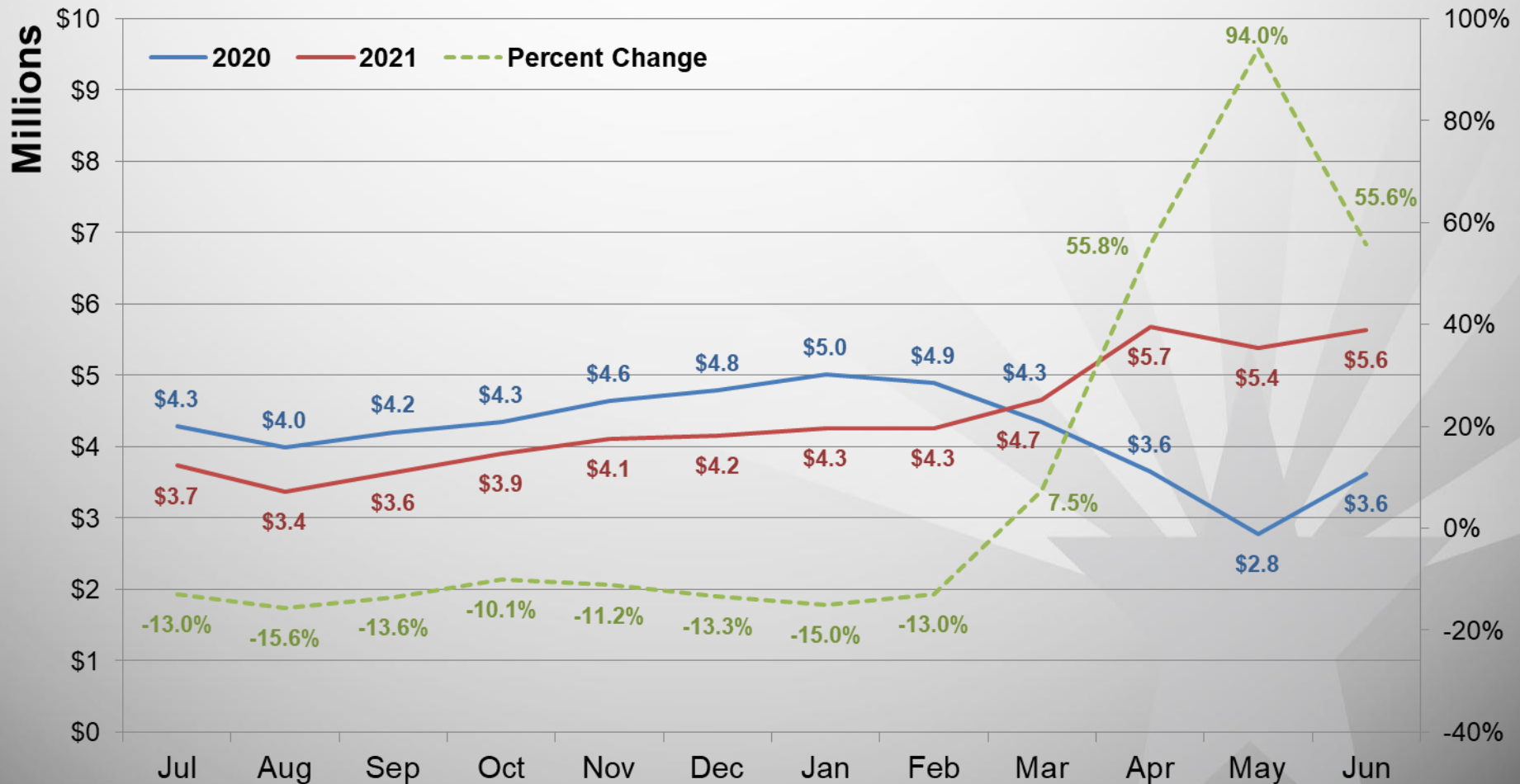
# Retail Sales: FY 2020 & FY 2021
