## Tribal Transportation Updates

### **FY22 Inter Tribal Council of Arizona - Tribal Liaison Support & Transportation Working Group (TWG) Project**

- This project enables ITCA and ADOT to conduct TWG meetings for state and federal transportation information sharing with Tribal transportation officials.
- TWG Meeting #2 was held on March 10th covering the Tribal Transportation Program, Tribal Road Maintenance Program, Tribal Bridge Program and related Bipartisan Infrastructure Law provisions.
- Planning is underway for a 3rd TWG meeting to be held on April 7th with FTA Region 9 presenting on the Tribal Transit Program and FHWA presenting on Transportation Safety Programs.

## Tribal Transportation Updates

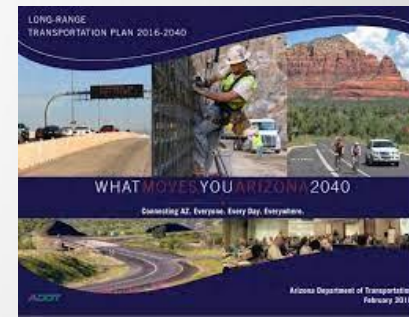
### **2022 Arizona Tribal Traffic Safety and Injury Prevention Summit**

- Summit focus: To present strategies and resources that prevent and reduce Tribal traffic crashes and community member personal injury.

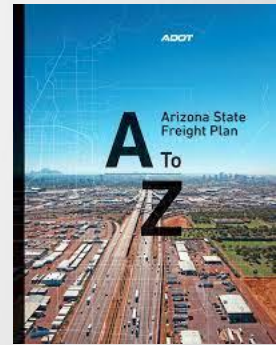
# ADOT-MPD Planning Updates

## Long Range Transportation Plan (LRTP) Update

- Purpose is to provide information and direction on:
  - Transportation needs;
  - Available revenues;
  - Investment priorities; and
  - Anticipated system performance
- Is policy oriented rather than project specific
- Covers a 25-year horizon
- Must be completed every 5 years; update is due in 2023
- Consultant proposals are due March 30, 2022



# ADOT-MPD Planning Updates



## Arizona Freight Plan Update

- Purposes:
  - Provide information to understand the importance of freight
  - Define short-term and long-term investment priorities to meet freight movement needs and support Arizona's economy
  - Meet federal requirements for freight planning
- Must be completed every 5 years; update is due before end of 2022
- Assisted by Freight Advisory Committee (gov't and industry members)
- Currently underway; in the process of identifying issues and needs
