# Tribal Transportation Updates

## **FY22 Inter Tribal Council of Arizona - Transportation Working Group (TWG) Project**

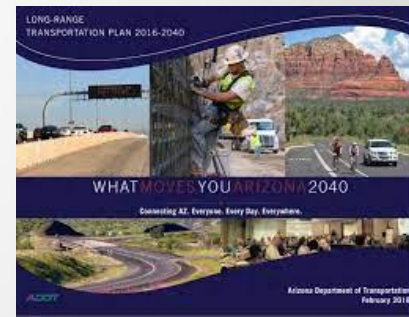
- TWG Meeting #3 was held April 7th providing overviews of the Highway Traffic Safety Improvement Program and the federal Tribal Transit Program as well as related Bipartisan Infrastructure Law provisions for program
- Nine representatives from 6 tribes attended the meeting.
- Planning is underway for TWG meeting #4 to be held May 5th with ADOT staff presenting on the AZ Long Range Transportation Plan Update and the AZ Electric Vehicle Deployment Plan Project.

# Tribal Transportation Updates

## 2022 Multi State Agency Tribal Liaison Group - Tribal Leader Outreach Meetings

- Tribal Liaisons from ADOT, Advisory Council on Indian Health Care, Department of Child Safety, Department of Economic Security, Department of Education, First Things First, Health Care Cost Containment System, and Office of Tourism are planning to conduct Tribal Leader - State Agency Group Outreach meetings.
- Generally the expected purpose of the outreach meetings would be to provide an orientation covering:
  1. Tribal Liaison roles and responsibilities
  2. Agency Tribal Consultation Policies
  3. Current agency tribal outreach activities
  4. Discussion on recommendations for improved outreach

## Long Range Transportation Plan (LRTP) Update

- Must be completed every 5 years; update is due in 2023
- Consultant proposals currently under review (2)

## National Electric Vehicle Infrastructure (NEVI) Program

- State Plan is due August 1, 2022
- Consultant proposals currently under review (3)

**Tribal Consultation and Tribal Liaison involvement is a requirement of both these plans**
