- Eligibility is subject to change with release of 2020 urbanized areas expected in Dec 2022



AZ SMART Board Policy

Substantive provisions proposed:

- Provide awards during term of IIJA (effective 11/16/21) to well-developed applications to help maximize successful ROI
- Allocate funds in each category while allowing Board flexibility:
 - Small applicants: 50/40/10 between Match, Design and Grant Development
 - Large applicants: 50/50 split between Match and Design
- Board approves Application and Guidelines
- Board may give preference to Applications as follows:
 - Based on percentage of matching cash funds provided by Applicant;
 - Partnership with other entities to deliver the project
- Require applicants to respond within 5 business days to inquiries
- Require applicants to execute IGAs within 120 days of Board award or federal grant agreement execution
- Require all awards to be subject to federal, state and ADOT laws and policies

- Applications will be continually accepted

- Features checklist of required documents and information at top
- First submission required to include approved and signed Master IGA* or application will not be considered
- Includes standard questions regarding Project scope, schedule and budget
- Includes notes to remind Applicants of key points such as the necessity for good cost estimates
- Requires identification of the federal grant to be pursued
- Incorporates action taken by the Board
- Upon approval and execution, each application will become an Amendment to the Master IGA
- Administrative changes may be required but major changes will be brought to the Board

*The term of the Master IGA is through the end of IIJA

Application Guidelines

Background

The AZ SMART Fund was established by the Arizona Legislature in 2022 to assist eligible cities, towns, counties and the Arizona Department of Transportation (ADOT) in applying for and winning federal discretionary surface transportation grants. The Fund is administered by ADOT, and all awards must be approved by the State Transportation Board (STB).

The AZ SMART Fund is funded at \$50 million for state fiscal year 2023. The monies are allocated to certain categories of eligible applicants as follows:

- 20%, or \$10 million, for counties with a population of 100,000 persons or more;
- 20%, or \$10 million, for counties with a population of fewer than 100,000 persons;
- 20%, or \$10 million, for cities and towns with a population of 10,000 persons or more;
- 20%, or \$10 million, for cities and towns with a population of fewer than 10,000 persons; and
- 200/ or \$10 million to ADOT

Expected Launch Timeline

- October 21st Board approval
- November 1st AZ SMART website goes live
- November 7th AZ SMART application goes live and applications begin to be accepted
- November 17th Informational webinar for Applicants
