
### **Background**



- Approval Process and Schedule:
  - **February 17, 2023:** Tentative Five-Year Program Approved by the STB
  - May 19, 2023: Public Hearing
  - June 1, 2023: STB Study Session to discuss comments
  - June 16, 2023: Request Final Approval of the Five-Year Program
  - July 1, 2023: FY 2024 begins
- STB Five-Year Program must be fiscally constrained



The programming cycles for MAG and PAG vary from ADOT's. The MAG and PAG sections of the final program are subject to amendment as both entities update their TIPs.


















# Greater Arizona (excludes Maricopa and Pima Counties)





### **Changes to Draft Final**

- Restored barrier protection project for Page, San Simon, Topock, Sanders, and Yuma ports of entry \$940K in 2024
- Restored US 180 Corridor improvements for \$350K in 2024 and \$3.2 Mil in 2025/26
- Added project assessment for \$250K in 2024 for US 191/I-10 interchange
- Movement of projects between years to accommodate changes above and maintain fiscal constraint
- Minor edits to narrative sections of the program
- Minor corrections to project names, locations, work types, fund sources
- Maricopa County section will show 2024 and 2025 only
- Changes in MAG and PAG unprogrammed amounts as they refine their programs

# Status regarding Major Themes as of Proposed Final 2024-2028 Five Year Program

#### SR 260 - Pavement - Payson through White Mountains area

Lions Springs Section widening (5 mi) programmed for FY 2025-2027 Construction

Overgaard to Campland Rd (6.88 mi) pavement life extension programmed for FY 2024 Construction

Knottingham Ln to MP 357 through Pinetop/Lakeside pavement rehab (11 mi) programmed for FY 2027 Construction

Knottingham Ln to Lakeside Fire Dept mill and replace of spot improvements (8.8 lane mi) - approved by Board on

4-27-23

Penrod Ln to Buck Springs Rd mill and replace of spot locations (1.2 lane miles) - approved by Board on 4-27-23 Also: To improve SR 260 in Navajo County - state legislative appropriation of \$4,250,000 in FY 2024

#### I-10 - Add interchange/improve flow at Jackrabbit Road

Interchange is programmed for FY 2024 Construction
Also: For FY 2024, the State Legislature appropriated \$5M to Design the interchange

#### Widen/improve safety on SR 347 in City of Maricopa area

West Juan Street to I-10 (13.3 mi) programmed for pavement preservation in FY 2027
I-10 to City of Maricopa widening design (15 mi) is in the current Program for FY 2023
Riggs Road Overpass is in the current Program for FY 2023 and programmed for FY 2025 Construction
SR 238 to Maricopa City Limits (1.4 mi) is in the current Program for FY 2023 Construction

Also: State legislature redistributed \$10M to Maricopa to design and construct SR 238 and/or SR 347 improvements

### Status regarding Major Themes (Cont'd)



#### I-10 Pima County-Benson congestion/access

Country Club to Kino general purpose lanes and interchanges programmed for FY 2024-2026 Construction Alvernon to Valencia widening (2.16 mi) programmed for FY 2025-2026 Construction Climbing lane westbound between SR80 and SR90 (0.5 mi) programmed for FY 2024 Construction *Also:* ADOT will investigate I-10 capacity and access road concerns for J6 and Mescal areas west of Benson

#### I-17 - Pavement conditions

SR 74 to Anthem Way (4.61 mi) pavement rehab programmed for FY 2025 Construction Mill and replace of the following spot locations approved by Board on 4-27-23:

- SR 169 to Middle Verde Rd (3 lane miles)
- SR 169 to 1 mile north of SR 179 (2 lane miles)
- SR 179 to Scenic Outlook (10 lane miles)
- Sunset Point to SR 69 (2.43 lane miles)
- SR 69 to SR 169 (1.23 lane miles)

#### I-10 Phoenix to Casa Grande - Widening

Gila River Bridge replacement/widening in the current program for FY 2023 Construction Riggs Rd to SR 387 (17.9 mi) Programmed for ROW in FY 2024 and Construction in FY 2025 Also: New state legislative appropriation of \$89M for FY 2024 for Chandler to Casa Grande segment

#### I-40 - Pavement conditions

Needle Mt T.I. to Lake Havasu T.I. pavement rehab (5.9 mi) programmed for FY 2024 Fort Rock to Markham Wash pavement rehab (15.7 mi) programmed for FY 2024 Townsend-Winona Rd to Buffalo Range Rd mill & fill (12 mi) programmed for FY 2024 Pinta to McCarrell pavement rehab (11.8 mi) programmed for FY 2024 Holy Moses Wash to Rattlesnake Wash pavement rehab (10.08 mi) programmed for FY 2025 Two Guns to Dennison pavement rehab (9.3 mi) programmed for FY 2025 US 93 to Silver Spring Rd pavement rehab (8 mi) programmed for FY 2027 Mill and replace of the following spot locations approved by Board on 4-27-23:

- Riordan Bridge to I-17 (8 lane miles)
- Walnut Canyon Rd to Townsend-Winona Rd (11.2 lane mi)
- SR 99 T.I. to Tucker Flat Wash (11.2 lane miles)
- Fort Rock to Seligman (7.5 lane miles)
- Cross Mountain to Willow Ranch T.I. (1.2 lane mi)
- Seligman to Ash Fork (7 lane miles)
- Willow Ranch T.I. to Fort Rock (0.44 lane miles)
- US 93 to Silver Springs Rd T.I. (0.69 lane miles)
- Needle Mountain Rd T.I. to Lake Havasu T.I. (0.69 lane miles)
- Pinta T.I. to McCarrell T.I. (1.6 lane miles)
