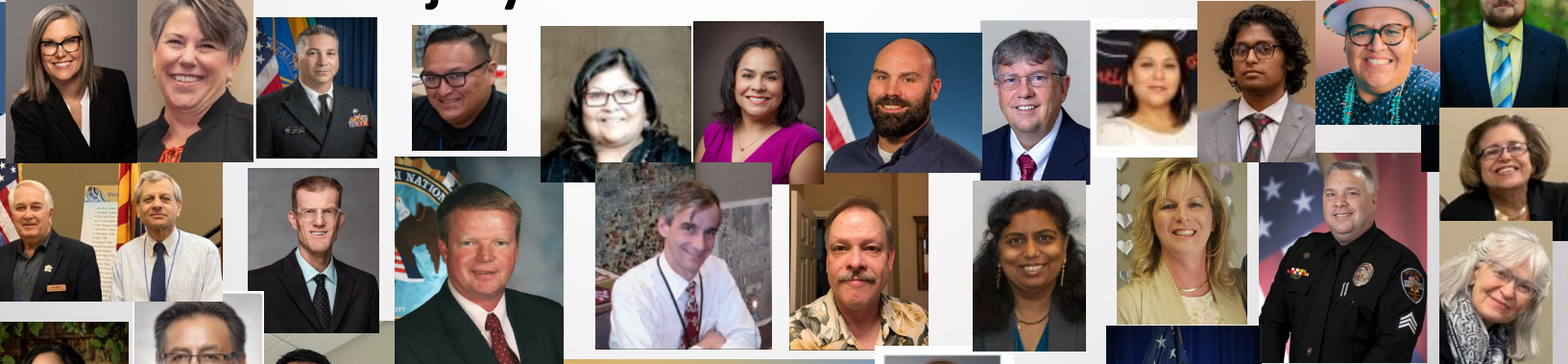

Tribal Transportation Updates

STATEWIDE ACTIVITY

Tribal Transportation Program Coordinating Committee Meeting

- The Navajo DOT hosted this national meeting on July 25-27 at the ADOT Northcentral District Office in Flagstaff. The TTP is the major source of transportation funding for the 574 Tribes/Native Nations across the country. The Coordinating Committee provides input and recommendations to the BIA and FHWA in developing TTP regulations, policies and procedures; BIA, and FHWA.
- The Committee consists of Tribal representatives from the 12 BIA Regions. For Arizona the BIA Navajo Region was represented by Jonah Begay of the Navajo DOT and the BIA Western Region was represented by Sandra Shade from the Ak Chin Indian Community Planning and Development Department.
- Mr. Chandler Willie was introduced as the new Navajo DOT Division Director replacing Mr. Garrett Silversmith.

NORTHERN ARIZONA REGION ACTIVITIES

USDOT Rural and Tribal Assistance Pilot Program –

ADOT/Hopi Tribe SR 264 Grant Application

- MPD has collaborated with the Hopi DOT to develop and submit a grant application project under the recently announced RTAP Program. The project is to develop an SR 264 Corridor Preliminary Engineering Scoping Report that will address transportation safety improvements on the Hopi Reservation. The project area would run from BIA Route 2 to SR 87.
- This effort is in consideration of several meetings including two Arizona State Transportation Board Meetings where Hopi Tribal officials commented on SR 264 issues and the need for safety improvements.

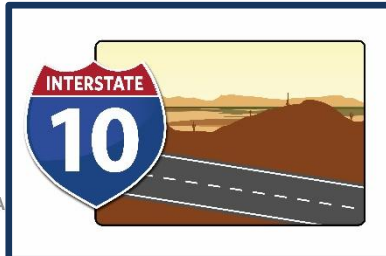

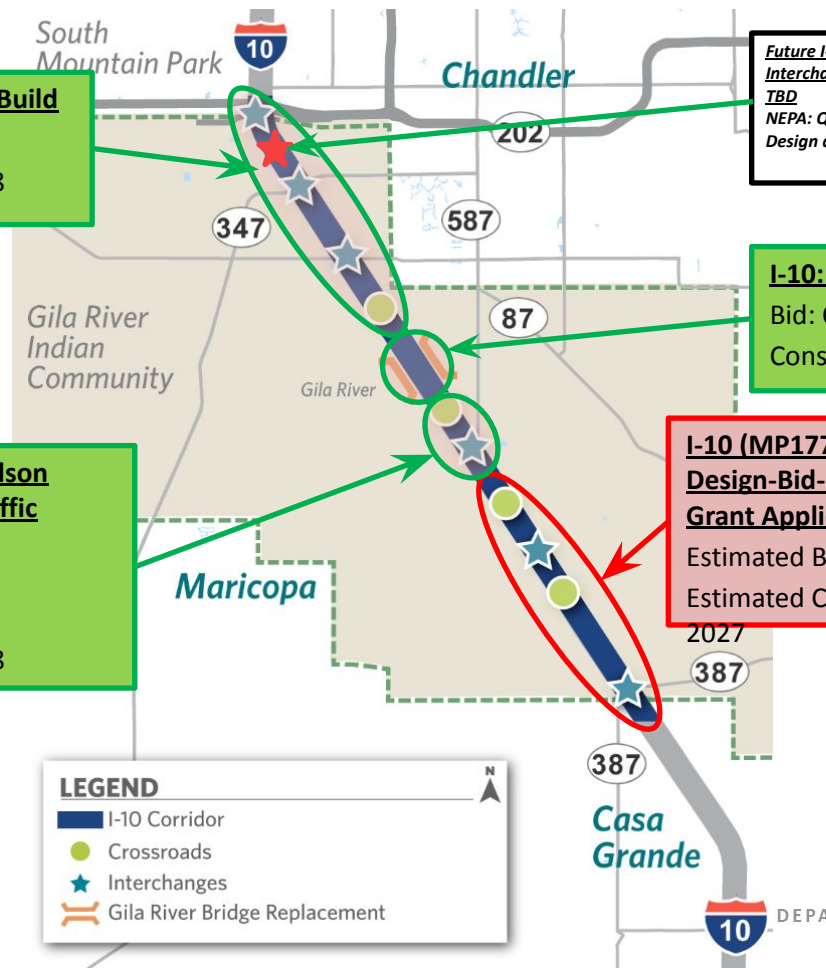

Truck Parking Plan Update

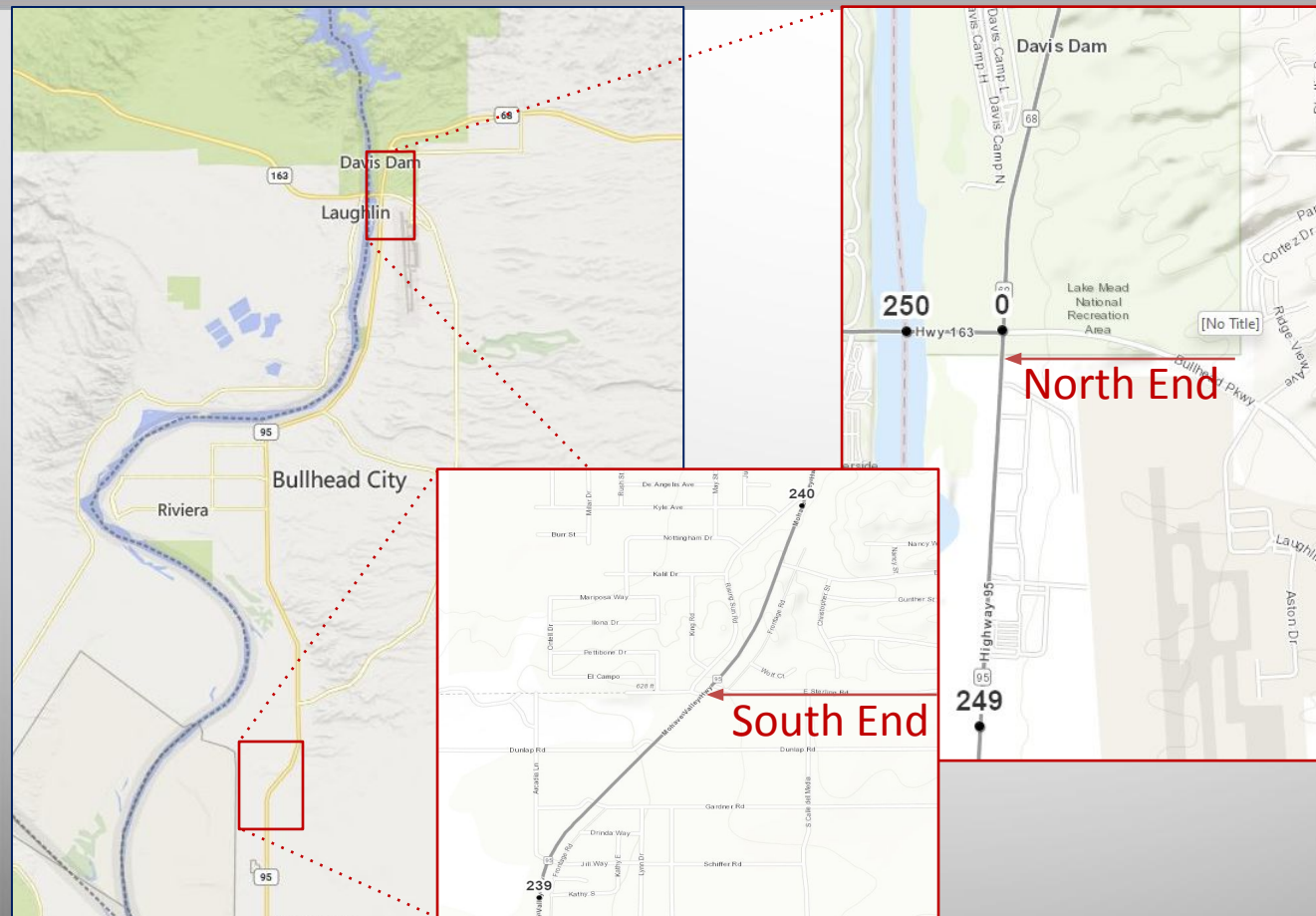


SR 95 ROUTE TRANSFER

Length – 10.2 Miles:

- North End - is just south of SR 95 & Bullhead Parkway intersection (MP 249.75)
- South End - is at SR 95 & Sterling Ave (MP 239.57)

PROGRESS TO DATE

- Several discussions were had between the Department and the City of Bullhead City to understand the needs and benefits of this effort.
- The completion of the Department's current paving project through the City was seen as a good starting point for the City to take over SR 95.
- The City is in favor of having the freedom to manage and develop the corridor for their needs.
- The route transfer will provide an opportunity for the City to complete their own design and construction of turn lanes along SR 95 with recently awarded state funds.
- July 18th, 2023 – The Bullhead City Mayor and City Council Passed and Adopted a resolution supporting the transfer of State Route 95.
- July 26th, 2023 – Bullhead City Letter of Intent was sent to the Department.
- August 2nd, 2023 – Department met with Mayor and City Manager to discuss terms and understanding for draft agreement.
- Draft Intergovernmental Agreement (IGA) has been started.
