## **AZ SMART Eligibilities**

Eligible Uses include:

- Reimburse up to 50% of grant development and submission costs of a federal grant application. Limited to:
  - Counties with population of less than 100,000 and
  - Cities/towns with population of less than 10,000
- Match for a federal grant
- Reimbursement for design and other engineering services that meet federal standards for projects eligible for a federal grant

**Eligible applicants** are ADOT, all cities/towns and counties outside of Maricopa and Pima Counties, and Gila Bend in Maricopa County

Local and Regional Project Assistance (RAISE)	The RAISE program provides supplemental funding for grants to the State and local entities listed above on a competitive basis for projects that will have a significant local/regional impact. Highway, road, bridge, public transportation, passenger and freight rail, port infrastructure, replace/rehabilitate a culvert, prevent stormwater runoff to improve habitat for aquatic species, any other surface transportation infrastructure project the Secretary considers to be necessary
Reconnecting communities pilot program	For projects that reconnect communities by removing, retrofitting, or mitigating highways or other transportation facilities that create barriers to community connectivity, including to mobility, access, or economic development.	State, Tribal Governments, Counties, Cities, Nonprofits and others.	A highway, including a road, street, or parkway or other transportation facility, such as a rail line, that creates a barrier to community connectivity, including barriers to mobility, access, or economic development, due to high speeds, grade separations, or other design factors.
Rural surface transportation grant program	Rural Surface Transportation Grant Program will support projects to improve and expand the surface transportation infrastructure in rural areas to increase connectivity, improve the safety and reliability of the movement of people and freight, and generate regional economic growth and improve quality of life.	State, Regional transportation planning organizations, LG, Tribal government, Multijurisdictional entities.	Eligible highway, bridge, or tunnel projects; highway freight projects; highway safety improvement projects; projects on a publicly-owned highway or bridge improving access to certain facilities that support the economy of a rural area; integrated mobility management system, transportation demand management system, or on-demand mobility services.




