Legislative Session Updates

- The Legislature adjourned on June 15th, after 160 days of session, making the General Effective Date September 14th.
- There were 332 bill sent to the Governor. As of today, 226 bills have been signed, 69 have been vetoed and the remainder are awaiting action.
- The Governor signed HB 2438 on June 18th, which continues ADOT for 8 years.
- Board Members Elters, Howard and Peshlakai were all officially confirmed by the Senate on June 14th.
