AZ Tribal Transportation Safety Roundtable & AZ Rural Transportation Summit - Tribal Component Update

- The AZ Tribal Transportation Safety Roundtable planned for September 18-19 has been canceled with consensus from the core planning team.
 - It was determined that the scheduled Tribal Roundtable would conflict with a major Tribal event to be held on 9/18 and also limit participation at several major Arizona transportation conferences to be held soon after. This also takes into consideration travel time and costs for Tribal officials.
 - The Tribal Roundtable is anticipated to be rescheduled in 2025.
- ADOT Tribal outreach efforts will now focus on the Tribal component of the 2024 Arizona Rural Transportation Summit to be held on October 16-17.
 - The ADOT Tribal Relations Team is finalizing an agenda for a Tribal Track and Listening Session on October 16, in coordination with CYMPO, the lead agency and organizer for the Rural Transportation Summit.
 - A Save-the-Date announcement is forthcoming, and additional information will be disseminated to Tribes this month.

ADOT Strategic Highway Safety Plan & Alternative Transportation Safety Action Plan - Tribal Outreach Update

- ADOT is in the process of developing the Arizona Strategic Highway Safety Plan (SHSP) and Active Transportation Safety Action Plan (ATSAP). ADOT recently hosted several Safety Stakeholder Workshops for local jurisdictions, transportation safety experts and Tribal Nations. Also formal Public Meetings where completed throughout the State.
- Tribes were notified and invited to these events and given the opportunity to provide comments on the Plans and encouraged to participate on a SHSP Tribal Lands Focus Area Team. The upcoming Team meetings would allow additional opportunity to strategize on future Tribal transportation safety initiatives.
- ADOT also expects to conduct Tribal outreach in August when the SHSP and ATSAP draft plans are expected to become available for public review. This is to ensure Tribes are aware of the opportunity to provide comments and will include invitation for virtual one-on-one meetings.

Tohono O'odham Nation - Strategic Transportation Safety Plan

- On July 1, 2024, the ADOT Traffic Safety Group, ADOT Southcentral District and ADOT MPD participated in a Stakeholder/Public Meeting for development of the Tohono O'odham Nation 2024 Strategic Transportation Safety Plan Update.
- The Nation's Project Team provided an overview of the draft priority findings from the plan with focus on several Indian Routes and State Route 86.
- ADOT representatives provided input on the Arizona Strategic Highway Safety Plan Update, ADOT Traffic Records and Criminal Software Program and ADOT Highway Safety Improvement Program.
- The Nation's project team will continue to accept community input through July and the final report is expected to be completed in August.
