

Jan 2025 Redistribution

- At Board's option, may be done each January and July
- Fund must be redistributed equally across all five Funding Categories
- Amount available for Redistribution is \$18,705,021.61
- ADOT, Muni <10K and County <100K give up the amounts outlined in red; Muni 10K+ and County 100K+ are recipients of these funds
- All Funding Categories will be reset at \$3,741,004

Requested Action

 Approve the redistribution of the total amount available for awards in January 2025 equally across all five funding categories as shown in previous slide.


