HB2192: Appropriations; Interstate 10; vehicle lanes

- Appropriates \$70M in FY25-26 and \$50M in FY26-27 for the design and construction of additional vehicle lanes, separated by a lighted median, on I-10 between SR 85 and Citrus Rd.

HB2557/SB1617: Appropriation; State Route 347

- Mirror bills appropriating a net increase of \$41.4M from the GF for ROW/utilities/cultural recovery and construction of Riggs Road/SR 347 Traffic Interchange.
